- 1.3.2. Dissemination of copies of product by any mean;
- 1.3.3. Import of the original or copies of product with the purposes of dissemination;
- 1.3.4. Finishing of product to overall data by transfer to an aether either on a cable or by means of other analogous resources.
- 1.4. The terrain on which product usage is admitted is not limited.
- 1.5. The rights of usage of product are granted the Licensee with conservation for the Licensor of the right of licensing to other persons.

## 2. The rights and responsibilities of the Sides

- 2.1. The licensee can use product only within those rights and those means which are provided by the present license agreement.
- 2.2. From the written approval of the Licensor the Licensee can accord under the sublicense agreement the right of usage of product to other person within those rights and those means of usage which are provided by the license agreement for it.
- 2.3. During the period of validity of the license agreement the Licensor is obliged to abstain from any acts, capable to hinder realization by the Licensee of the right of usage of product granted it in the limits installed by the present agreement.

## 3. The period of validity of the contract

- 3.1. The rights indicated in item 1 of the present agreement, are passed by the Licensor to the Licensee to period of validity of copyrights.
- 3.2. In case of the termination of the exclusive right the license agreement stops.

### 4. Remunerating of the Licensor

4.1. For product usage payment of any remuneration is not provided. The delegation of rights for usage of product is carried out on a gratuitous basis.

# 5. Responsibility by agreement

- 5.1. For usage of product by the means which has not been provided by the present agreement, or after contact termination, or otherwise outside of the rights granted by the agreement, the Licensee bears responsibility for breaking of the exclusive right to the product, provided by the Civil code of the Russian Federation and other regulatory legal acts.
- 5.2. The licensor secures availability of exclusive rights represented on the present agreement to product.

### 6. Final provisions

- 6.1. The present agreement becomes effective from the moment of its signing.
- 6.2. The present agreement is constituted in two authentic copies on one for each of the Sides.
- 6.3. In all that it is not provided by the present agreement, the Sides are guided by the current legislation of the Russian Federation.
